# **GUEST INFORMATION FOLDER**

## Health & Safety

We take the utmost care to adhere to all Health and Safety Regulations and to ensure the highest possible standards are maintained at all times. However, should you notice anything that represents a health or safety hazard we would request that you notify the Management at once so that any necessary action can be taken with the minimum of delay. Please be advised that children under 16 years must NOT be left on their own in the property.

#### **Emergencies – Fire Precautions**

Your property has a fire/smoke alarm system, fire extinguisher, fire blanket and a carbon monoxide alarm. Please carefully read the instructions displayed in your cottage. As a fire precaution all internal doors should be shut prior to going to bed. Please note the fire alarm in the pool complex is tested weekly.

In the event of a fire in your cottage, do NOT attempt to tackle the fire yourself. Keep calm and do not stop to collect any belongings. Make your way out of the property by the safest and nearest exit and go to the fire assembly point. Notify reception or if unattended, call 999. Do not re-enter the property until you have been told it is safe to do so by the Duty Manager or Fire Officer.



### Woodburner



The woodburner operates very efficiently and requires very little attention, however, please note the following points for your safety and comfort.

- ✓ Firelighters and kindling wood are required for the woodburner to operate effectively
- ✓ The vents should be fully open when lighting the fire
- Ensure the door is always closed when the fire is alight
- ✓ Do not put any plastic or combustible items in the fire
- ✓ Do not rest anything against the wood burner
- ✓ There should be no need to empty the wood burner during your stay however, if it is full at any stage please advise reception and we will empty it do not empty it yourself
- ✓ Alongside the hearth is a laminated instruction leaflet for those not familiar with laying a fire.

#### Woodburner Logs

An initial supply of kindling and logs are available from Reception (limited opening hours). Further supplies can be purchased from the local petrol station, about a mile away. Turn right from our entrance, follow the road down and turn left onto the main road.

### Smoking & Vaping

Smoking and vaping are **STRICTLY PROBHIBITED** in any area of your cottage. There are two designated smoking areas with fire-safe cigarette bins (one outside reception and another in the bike shelter) and we kindly ask that for the consideration of your fellow guests and non-smoking neighbours, that you use these designated areas whenever you are smoking/vaping. A penalty charge will apply to the lead booker if anyone in the party fails to comply as this is a legal requirement.

#### Drugs

If anyone is discovered using non-prescription/illegal substances, they will be required to leave the property immediately.



We would ask that you and members of your party carefully read the following important notes so you can safely enjoy this facility. This advice is especially important in respect of children and swimmers who are not fully competent. It is therefore a condition of use that all guests fully comply with these safety instructions.

- ✓ Pool depth is 1.25 metres throughout
- ✓ We do NOT have a lifeguard on duty
- $\checkmark$  Children under 16 years must always be accompanied by an adult

The pool door is accessed by a security code detailed on the laminated sheet in your cottage

- ✓ Competent adult swimmers must supervise children under 16 years and non-swimmers at all times
- ✓ It is prohibited to use the pool on your own. For obvious health and safety reasons a responsible person 16 years or over must be in the pool room if there is a lone swimmer.
- $\checkmark$  Do NOT use the pool outside the stated opening hours as shown in reception or when there is a closed sign and/or the lights are off
- ✓ Take care when swimming close to the steps
- ✓ Diving, jumping and inflatable toys are strictly prohibited
- ✓ The poolside is strictly non-smoking and there is NO eating or drinking in the pool complex
- ✓ You are strongly advised NOT to swim soon after a meal or having consumed alcohol.
- $\checkmark$  Do NOT use the pool if it is too crowded
- ✓ The Management and staff have the right to remove anyone from the pool who they believe is not complying with the above rules
- ✓ The access door to the swimming pool has an automatic closing device. Please ensure the door is always closed after entering or leaving.
- ✓ In the event of an emergency please press the poolside alarm button, however, please note reception is only manned at restricted times of the day and there is no lifeguard
- ✓ Please dispose of swimming nappies in the hygiene bin in the toilet area by reception
- Please do not use music/portable speakers in the pool area

Please note that the swimming pool may be subject to closure or restricted use in line with any safety requirements which may be imposed at any time by the government, local authorities, or for any other operational, health or safety reasons.

## Food & Drink



The Crown Inn, Lanlivery

The Crown Inn in Lanlivery, is Just half a mile from Green Acres.

The Rashleigh Arms and Sam's On The Beach is in Polkerris.

The Ship Inn is in Par and The Britannia is on the main road from St. Blazey to St. Austell (by Par market).

There is an Indian restaurant **The Indian Ocean** on the main road from St. Blazey to St. Austell, just under a mile away. They also offer a take-away service and will deliver (01726 816452). <u>www.indianoceanstblazey.co.uk</u>

There is also a wide range of bars and restaurants in nearby Fowey, Carlyon Bay, Lostwithiel and Charlestown, the popular World Heritage site which is around 6 miles away.

# Housekeeping

Your property has been fully serviced for your arrival. Each property has some basic cleaning materials. We would ask guests to leave the property in a clean and tidy condition.

In the unlikely event there are damages in the property upon arrival, please notify reception as soon as possible (see page 8).

Bedding & Towels	For stays of 8 nights or longer, we will automatically supply additional bedding/towels halfway through or weekly. For any other bedding requirements please contact Porth Veor Manor reception on 01637 873274 – see page 8 for opening hours. Please do not take our towels to the beach.
Bath Mat	Rubber bathmats are supplied for your safety. Please take care when stepping in and out of the bath/shower.
Cots & High Chairs	These are usually stored in the under stairs cupboard or by the front door.
Heating	The property has an under-floor heating system throughout with individual thermostat controls. These systems are highly efficient and cover a large floor area, therefore, they can take up to 6 hours to heat up or cool down properly.
Iron & Ironing Board & Airer	These are provided in all properties. We would respectfully request that guests do not hang any item of clothing or laundry on any balcony railings.
Laundry	There is no laundry facility on site, however, there is a launderette in Par at Snowland Holiday Park PL24 2AE and it is open daily to non-residents.
Sofa Bed	If you have booked maximum occupancy including use of the living room sofa bed, the bedding can be found in the monk's bench, storage cupboard in the lounge/hall or in the bedroom wardrobe.
Tea & Coffee	A welcome pack of tea, coffee, milk and sugar sachets is supplied.
Waste / Rubbish	Our dustbin enclosure is located by the entrance to the complex through the double wooden doors. Please ensure that all waste bags are securely fastened before placing in the bins. There is a separate recycling bin for cardboard, plastic containers, paper, food tins and drink cans plus there is one for glass. Please shut the gates after use. Please do not dispose of any sanitary products, wipes or nappies down the toilet as it may cause a blockage.

If you require any assistance with the operation of the heating or assistance in operating any appliance, please contact Porth Veor Manor reception on 01637 873274.

With specific regard to appliances such as the dishwasher, cooker, iron etc., please do NOT leave any of these operating whilst away from the property. Also, please ensure the hairdryer is cool before placing it in the drawer.

The Green Acres reception is located by the main entrance to the pool complex, however the opening hours are limited. Keys	Please keep your front door key with you at all times and when leaving the property, ensure all doors and windows are secure. Please do not remove any patio door keys for obvious safety reasons. On check out please place the key back in the key safe by the front door and scramble the numbers.
Valuables	The Management cannot be held responsible for any loss and/or damage of valuables and advise that they are always kept with you.

Go through Tywardreath Village, turn left down Tehidy Road and at the junction turn right and the surgery is on the left.</li> <li>Repeat prescriptions are available at 48 hours notice, subject to your circumstances. Alternatively, you can also ring NHS Direct 24hrs a day on 111.</li> </ul>
Hospital	A&E department at the Royal Cornwall Hospital, Treliske, Truro Tel: (01872) 250000. There is also a minor injuries unit at <b>St Austell Community Hospital</b> , Porthpean Rd, St Austell, tel (01726 873000).
Chemist	The nearest chemist is <b>Boots Pharmacy</b> , 4 Fernlea Villas, St. Blazey, Tel. (01726) 815498. There is also a <b>Boots Pharmacy</b> at 29 Eastcliffe Road, Par, Tel. (01726) 812917 – see shopping section for directions.

Each cottage has its own private parking space commensurate with your property number that should be used at all times. For additional cars there is an overflow car park area.

### Shopping

The nearest shops are at **St. Blazey** (1<sup>1</sup>/<sub>4</sub> miles away). Turn right from Green Acres and at the main road turn left. There are two small general stores, one with a sub post office and one with an off-licence.

**Tywardreath Village** is 1½ miles from Green Acres. Turn left at the Green Acres entrance and then right at the junction and continue until you see the sign. There is a butcher's shop here.

**Par** is 2½ miles away. You can access Par by continuing through Tywardreath, then turn left into Tehidy Road past the church, go down the hill and turn left at the junction and follow the road around. Alternatively go through St Blazey, turn left at the traffic lights and take the left junction over the railway crossing and just follow the road round. If you proceed along this road (one way system) with the coast on your left, continue over the railway crossing and there is a fruit and vegetable shop on the left that also sells fresh fish.

Petrol Station	For the nearest filling station turn right from Green Acres and turn left at the main road and follow this road to St Blazey where there are two filling stations.

In the event of loss, damage, breakages or if the property is left in an unacceptable condition resulting in additional cleaning costs, we reserve the right to make additional charges to cover the extra costs we incur. Examples include but are not limited to: if your toilet becomes blocked and it is found to contain sanitary towel/s, wipes, nappy or any other sanitary product; if you lose your property key/s (unfortunately the lock(s) will need to be replaced); late check out resulting in our housekeepers being delayed in accessing the property.

BBQs	Cottages 1 to 5 have a brick-built BBQ in the garden, but we regret the other cottages do not have such a facility and BBQs are not permitted on the patio.
EV Charging NOT permitted	Unfortunately, at this time we do not have electric vehicle charging points at any of our properties. For health and safety reasons we explicitly forbid the charging of EVs via a regular three-pin plug into our domestic sockets or using an extension lead trailing across the property or through windows. This applies to all electric vehicles (including E-scooters and E-bikes. Our electrical sockets are not designed to support such loads, and it would be too dangerous. Furthermore, such charging is not permitted under the terms of our insurance.

Noise	Please show consideration to others, especially early in the morning and late at night.

# Polite Notice To Guests With Dogs

Whilst there is no specific dog exercise area at Green Acres, the rural setting makes for fantastic walks, many being off-road. There is a public footpath nearby which leads to a valley around half a mile from the cottages.

Whilst we appreciate that the vast majority of dog owners are very responsible, for obvious health and safety reasons we wish to advise of the following basic rules which must be adhered to.

- ✓ Whilst on-site, dogs must be kept on a lead at all times and muzzled where necessary.
- ✓ Owners must take responsibility for clearing up any toilet/mess and ensure its safe disposal.
- ✓ Please note that dogs are NOT permitted on the first floor.
- ✓ Under no circumstances must dogs be left unattended in the property or left in the car overnight.
- ✓ Dogs are not permitted in any area at Porth Veor Manor, our sister hotel. This includes the swimming pool area, gardens, car park etc.
- ✓ Owners must take responsibility for the behaviour of their dogs as it is important no inconvenience or nuisance is caused to any of our guests. As such, any damage caused must be paid for.

For the benefit of all our guests, failure to comply with these rules will result in expulsion without any refund of monies for unused accommodation.
